WHEREAS at their Regular Council Meeting of June 22, 2020, Council approved Variance Order 12.06.273600/VO-20-01/03 for Owner and Applicant Dauphin Church of Christ 2004 Inc. c/o Richard Kirkpatrick, for Lot 2, Plan 42800 DLTO (220 Whitmore Avenue West) to vary the front yard setback from 7.5 metres (24.6 feet) to 2.0 metres (6.5 feet) with respect to the Affordable Housing Project at Parkland Crossing;

AND WHEREAS a condition of the above-noted Variance Order was for the City of Dauphin and Church of Christ 2004 Inc. to enter into a Development Agreement establishing the terms and conditions for the development of the land and the construction, design, and cost responsibility of services related to the Affordable Housing Project;

AND WHEREAS the City of Dauphin awarded funding provided by Manitoba Housing and Renewal Corporation (MHRC) to Church of Christ 2004 Inc.'s Affordable Housing Project, a condition of which was the construction of at least four dwelling units by March 31, 2023;

BE IT RESOLVED that Council accepts as information a Development Agreement between the City of Dauphin and Parkland Crossing 2004 Inc., a site plan for Phase 1 (one 4-plex) and Phases 2+ (up to three more 4-plexes) for the Affordable Housing Project, and a memorandum dated September 23, 2022 from the City Manager, noting that Church of Christ 2004 Inc. anticipates the completion of Phase 1 with the first four dwelling units by March 23, 2022 and recommending that the Development Agreement be approved;

FURTHER BE IT RESOLVED that Council agrees with the City Manager's recommendation and authorizes the Development Agreement between the City of Dauphin and Church of Christ 2004 Inc. for the Affordable Housing Project at Parkland Crossing to be signed and sealed by the Mayor and the City Manager on behalf of the City of Dauphin.
