i) Local Improvement Plan Bylaw 07/2023 – South-End Storm Sewer Upgrades

Public Hearing commenced at 5:04 p.m.

The City Manager noted that the south-end storm sewer upgrades are a required project. The Province is twinning Main Street South and putting in services roads. There will be no room for the water to move through that part of town as it has been and Provincial law states that a municipality cannot increase the rate of flow into a neighbouring municipality. A consultant was contracted to perform an engineering study for a design of retention ponds and underground piping to deal with the water, and the project that we have presented today is the result.

The Director of Finance noted that \$8.15 million is required for this project.

Mr. Alex Dmitruk submitted a question by email on Friday, July 21, 2023, stating that he is in support of the project and asked what allocation, if any, will be drawn from General or any reserve established for this project to lessen the tax impact as a result of this needed project.

The Deputy Mayor responded stating that during the preparation of the 2023 budget, when this drainage project was being discussed along with all other capital projects upcoming in the next few years, we identified we would need to borrow money as the reserves have been earmarked for those other projects. We decided that we would borrow for this drainage project, so therefore we could fund those other capital projects from our reserves in subsequent years. Furthermore, we have not yet identified the source or sources of our borrowing, and may ultimately borrow some funds from our reserve.

There were no members of the public in attendance at the Public Hearing and no objections were received.
